On 25 May 2018 a new chapter in EU data protection law will come into effect. *noyb* is looking forward to start enforcement actions under GDPR, as foreseen by Article 80 GDPR.

For this task we are currently building a pan-European team (4 to 5 persons), that will work on strategic litigation, including informal warnings, complaints with DPAs, civil law suits and class actions. We will focus on strategic, innovative and effective enforcement of wilful privacy violations. *noyb* is based in Vienna, but will focus on privacy violations of private actors across the European common market. We will work together with national institutions in the consumer, privacy and tech sector - and hopefully with you!
